

## **CONSENT TO THE COLLECTION AND PROCESSING OF PERSONAL DATA**

I hereby freely, by my own will and in my own interest, give consent to the UNION OF GRAIN EXPORTERS AND PRODUCERS (Taxpayer Identification Number (INN) 7708356494) (hereinafter referred to as the Union or the Operator), address: Sadovaya-Spasskaya str., 11/1, premises/room XLII / 49, 51, 107139, Moscow, for the processing of my personal data by means of maintaining databases using automated, mechanical, and manual methods, for the collection and processing of the following information (documents) related to my personal data:

- given name, patronymic (if any), surname;
- telephone number;
- email address;
- IP address;
- registration details;
- Taxpayer Identification Number (INN);
- position;
- place of employment;
- other data obtained as a result of using the functionality of the Union's website <https://forum.rusgrain.org> (hereinafter referred to as the Website) for the following purposes:
  - registration and provision of access to the functionality of the Operator's website,
  - providing the possibility of using the functionality of the Operator's website,
  - preparation and holding of all-Russian, international, exhibition, business, public events and cultural events organized by the Union,
  - creation of an account in the Unified Personal Account, provision of access to the use of the functionality, content, and services of the website, the Unified Personal Account,
  - formation of reference materials for internal information support of the Union's activities,
  - drafting, conclusion, performance, and termination of agreements with counterparties,
  - providing the possibility to read news, review information, view video materials and photo materials, participate in events,
  - providing the personal data subject with effective support, quality control, research on satisfaction with the quality of services provided,
  - establishing direct contacts with the personal data subject by means of communication, including electronic means of communication, including for the purpose of informing by sending emails and/or by other means regarding participation in events organized and/or conducted by the Union and/or its partners, including event customers, about the status of review of the registration application by the Union, as well as informing about services, special offers,
  - improving the quality of the Operator's services, convenience, developing new features and services of the Operator,

- execution of court decisions, acts of other bodies or officials subject to execution in accordance with the legislation of the Russian Federation concerning enforcement proceedings.

I am aware that, as a personal data subject, I have the following rights provided for by the Federal Law No. 152-FZ dd. 27.07.2006:

- The right to receive information concerning the processing of my personal data, including the information containing:
  - confirmation of the fact of processing of personal data by the Operator;
  - the legal grounds and purposes of processing;
  - the processing methods applied by the Operator;
  - the name and location of the Operator;
  - persons who have access to the personal data or to whom personal data may be disclosed;
  - the list of processed personal data and their source;
  - the periods of processing of personal data;
  - other information provided for by law.
- The right to access my personal data processed by the Operator;
- The right to demand that the Operator update, block or delete my personal data if such personal data is incomplete, outdated, inaccurate, obtained illegally or is not necessary for the stated purpose of processing;
  - The right to withdraw this consent in the manner set forth below;
  - The right to appeal the actions or inactions of the Operator:
    - to the Federal Service for Supervision in the Sphere of Communications, Information Technology and Mass Communications (Roskomnadzor);
    - in court.
  - The right to protect my rights and legitimate interests, including the right to compensation for damages and/or moral injury.

The request should contain my passport data for identification purposes. The Operator undertakes to consider the request within 30 (Thirty) calendar days following the date of its receipt.

I understand and acknowledge that:

- Refusal to provide this consent or its withdrawal will result in the impossibility of registering on the Operator's Website, creating an account, participating in events organized by the Operator, and using the functionality of the Website.
- After the withdrawal of consent, the Operator will cease processing my personal data, except in cases where the Operator is entitled to continue processing on another legal basis under Para. 2–11 Part 1 Article 6 of the Federal Law No. 152-FZ dd. 27.07.2006 "Concerning Personal Data" (performance of an agreement, protection of vital interests, implementation of justice, etc.).
- Withdrawal of consent does not affect the legality of the processing of personal data carried out by the Operator prior to the withdrawal.

The list of actions with personal data for which the consent is given: collection, recording, systematization, accumulation, storage, refinement (updating, modification), extraction, use, transfer (provision, making available), depersonalization, blocking, deletion, destruction of personal data.

The processing of personal data is carried out by means of mixed processing including transfer over the Union's internal network and over the Internet.

Should I decide to provide the Operator with any information (any data), I undertake to provide exclusively accurate and up-to-date information and may not mislead the Operator regarding my identity or provide false or inaccurate information about myself.

I understand and agree that the Operator does not verify the accuracy of the personal data provided by me, does not have the ability to assess my legal capacity, and proceeds on the basis that I provide accurate personal data and maintain such data in an up-to-date state.

For the purposes specified in this consent, I agree that the Operator may transfer my personal data to the following categories of third parties:

- Organizers and co-organizers of the events conducted by the Union for the purposes of ensuring participation in events, preparation of documents, and providing information;
- Technical contractors and IT providers that ensure the functioning of the Website and the Operator's information systems;
- Payment systems and banks for processing payments for participation in the events;
- Courier services and postal organizations for the purposes of delivery of documents and materials;
- Event partners (sponsors, exhibitors) for the purpose of organizing joint events;
- Audit, consulting, and legal companies in connection with the provision of services to the Operator;
- Authorized state bodies upon their official requests in cases provided for by the legislation of the Russian Federation.

This consent is provided in electronic form by:

- Filling out the registration form on the Website <https://forum.rusgrain.org>;
- Placing a mark in the field “ I hereby consent to the receipt and processing of personal data in accordance with the terms and conditions of the Consent to the Processing of Personal Data”;
- Clicking the “Register” button (or another button confirming registration).

The fact of placing the mark and submitting the registration form:

- Is equivalent to a handwritten signature of the personal data subject in accordance with Para. 2 Part 1 Article 160 of the Russian Federation Civil Code (simple electronic signature);
- Confirms that the personal data subject has received all necessary information about the Operator and the terms and conditions for personal data processing;
- Confirms consent to the terms and conditions of personal processing data to the full extent.

This consent is valid for 5 (Five) years following the date of its provision or until the achievement of all purposes of processing of personal data specified in this consent, whichever occurs earlier.

This consent shall cease to be in effect early in the following cases:

- The Operator receives a written withdrawal of consent from the personal data subject;
- Expiration of the validity period of the consent;
- Liquidation of the Operator.

The Operator undertakes to cease processing of personal data within 30 (Thirty) business days following the date of withdrawal of consent. The Union shall be entitled to continue the processing of personal data without my consent, if there are legal grounds, in particular, those specified in Para. 2-11 Part 1 Article 6 of the Federal Law No. 152-FZ “Concerning Personal Data” dd. 27.07.2006.
